We will utilize instructor notes throughout this course.

Course Format

As Paul Halmos noted, “The only way to learn mathematics is to do mathematics.” Hence, we will spend the majority of our in-person class time doing mathematics. In particular, there will be a balance between lectures and class exercises, which sometimes take the form of worksheets and quizzes. In addition, there will be weekly homework assignments designed to help you develop a mastery of the material. Finally, there will be four exams and a comprehensive final exam to assess your understanding of the material.

Learning Outcomes

Upon successful completion of the course, students will be able to

- Find limits graphically and evaluate limits analytically.
- Relate the derivative of a function to the tangent line.
- Evaluate the derivative of explicitly and implicitly defined functions.
- Explain Rolle’s, Mean-Value, and the Fundamental Theorem of Calculus with examples.
- Use first and second derivative tests to find extrema on an interval.
- Use derivatives and limits to accurately sketch the graph of a function.
- Relate the derivative and antiderivative of a function.
- Use the Riemann sum to define and evaluate the definite integral of a function.
- Use the Fundamental Theorem of Calculus to evaluate the definite integral of a function.
- Explain the concept of a differential equation with examples.
- Use separation of variables to solve certain differential equations.

Assignment Descriptions

Homework

To help develop a mastery of the material, students will be given several homework assignments that cover the material in greater depth. Students are expected to write out their answers with an appropriate amount of work shown. If a student has an excused absence, they will be given additional time to complete the assignment. However, the student must communicate with the instructor prior to the assignment deadline.

Worksheets

Worksheets are given to complement the lecture material. Some worksheets will be completed in class; others will be completed at home and turned in during the following class period. Students who are absent from class are expected to complete the worksheets on their own and turn them in during the following class period.

Quizzes

Quizzes are given weekly throughout the semester to assess your understanding of the material and to help you prepare for the exams. These quizzes will be administered in class; only those with an excused absence will be given additional time to complete the quiz. Again, the student must communicate with the instructor prior to the quiz date.

Exams

We will have four exams throughout the semester. These exams are intended to test your general understanding of the concepts covered up to that point, with a heavy emphasis on the main definitions, theorems, and problem-solving methods. These exams will be administered in class; only those with an excused absence will be given additional time to complete the exam. Again, the student must communicate with the instructor prior to the exam date.

Final Exam

A comprehensive final exam will be given during finals week. The final is administered in person; only those with an excused absence will be given additional time to complete the exam. Again, the student must communicate with the instructor prior to the exam date.

Attendance Policy

Class attendance is highly encouraged and partially monitored through quizzes. In the case of an excused absence, such as illness, athletic contests, or job interviews, students will be given a reasonable amount of

time to make up an exam or assignment. However, they are responsible for notifying the instructor prior to the absence. In the event of a long-term absence, we recommend that the student contact Student Affairs about the possibility of a withdrawal for the semester.
